In Case No. 22-418-GA-PIF, the PUCO approved an adjustment to Rider PIPP, Percentage of Income Payment Plan from \$0.001208 to \$0.007755 per CCF effective August 2, 2022. In Case No. 21-618-GA-RDR, the PUCO approved a change to Rider CEP, Capital Expenditure Program Rider. A typical customer using 70 CCF in a month will see an increase of \$6.38 or 4.7%.

This month's Gas Cost Recovery (GCR) charge for customers purchasing their natural gas from Duke Energy is \$0.9770504 per CCF, which includes a base GCR of \$0.93150000 and Ohio excise tax of \$0.0455504.

When shopping for a natural gas supplier, it may be useful to compare supplier offers with the standard service offer (SSO) rate available to eligible customers, which varies monthly based on the market price of natural gas. Price represents one feature of any offer; there may be other features which you consider of value.
